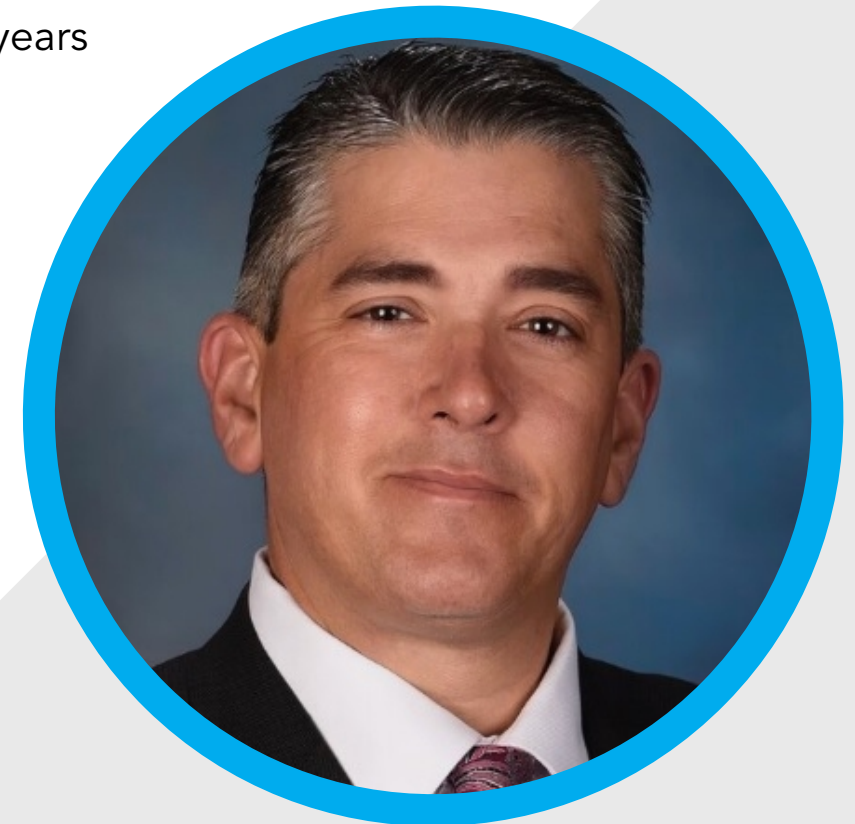

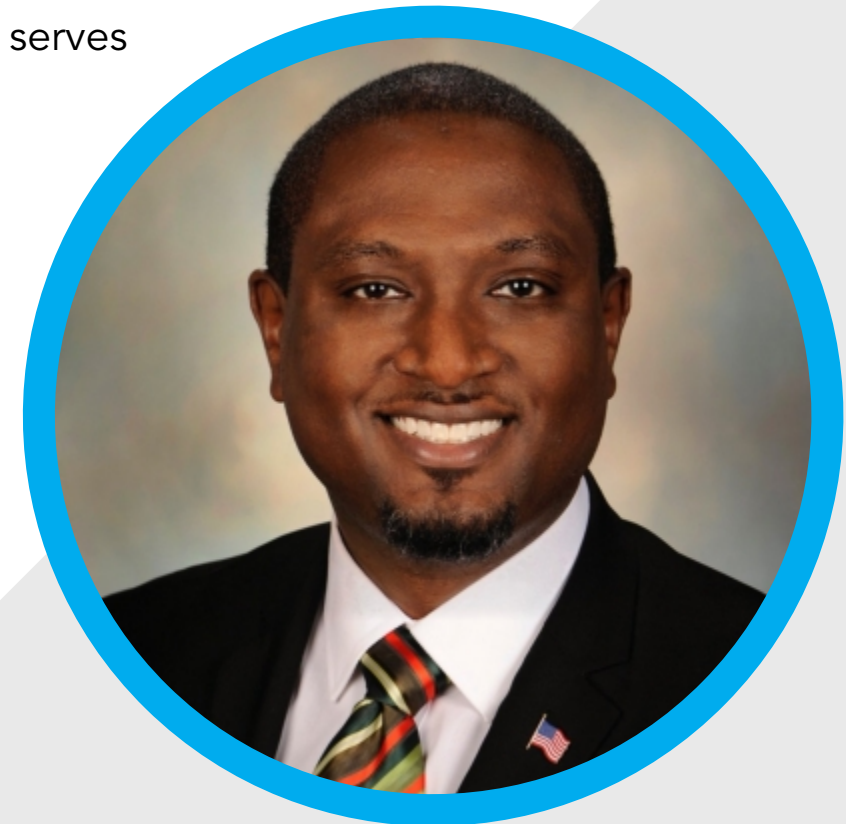

He is a two-time Legislator of the Year.

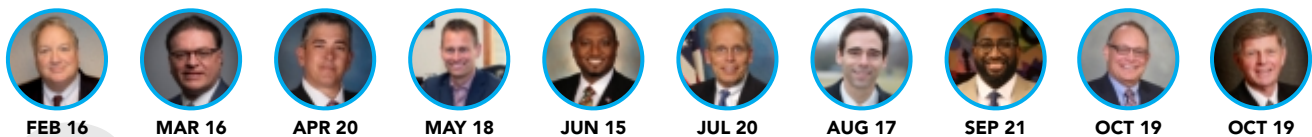
